#### MOAA LEGISLATIVE UPDATES

This is a summary of the many items MOAA produces each week on legislative activities.

#### MOAA's LEGISLATIVE UPDATE for October 29, 2010:

#### Disability Pilot Program Going Global

The Department of Veterans Affairs' Advisory Committee on Disability Compensation met this week in Washington and heard from the VA's Executive Director of the VA-DoD Collaboration Service, Mr. John Medve, who announced that the Disability Evaluation System (DES) pilot program will be expanded worldwide to replace the existing DoD legacy program over the next twelve months.

The pilot program came about as a result of the Walter Reed scandal in 2007 that uncovered wounded and disabled service members were receiving "low-balled" ratings as a result of the DES process.

Several commissions that investigated Walter Reed and the DES process recommended eliminating dual VA and DoD disability evaluations, but using one medical exam and having DoD use the VA disability ratings in evaluations by the Services' Physical Evaluation Boards.

The pilot, which has proven to improve the speed, effectiveness, and transparency of the DES review process, will expand from the current 27 sites to an additional 28 sites during this year's first phase. The system will be expanded to cover all remaining sites in additional three phases, with a target completion of October 2011.

LTG James Terry Scott (USA-Ret.), Chairman of the VA Advisory Committee, also announced that the committee plans to delve deeper into VA philosophy in assessing individual unemployability and the methodology behind presumptions.

Scott made the announcement at the two-day meeting where the committee received progress reports on the VA Schedule of Rating Disability re-write project and VA's roll-out of on-line Disability Benefits Questionnaires.

The DoD efforts are being led by Deputy Under Secretary of Defense for Personnel and Readiness John R. Campbell, a Vietnam-era veteran and Purple Heart recipient recently appointed to this position after leading organizational change at several fortune 500 companies.

"I have one expectation - results," Campbell told MOAA.

#### MOAA's LEGISLATIVE UPDATE for November 5, 2010:

MOAA joins the President in expressing our gratitude to all military people and families, who continue to be the saviors of our national well-being. We're pleased at the President's strong statement of the nation's reciprocal obligation to them, and pledge to do all in our power to ensure our government lives up to it.

#### Will Lame Ducks Limp Through or Fly?

Congress has gone all year fighting over the Medicare/TRICARE payment cuts, and has had real trouble coming up with ways to pay for even minor delays in the effective date. In a post-election session that's likely to be more contentious than ever, what are the odds the two sides can come to an agreement during the last couple of weeks of

November? Congress already let the cuts take effect once this year, and then took a month to fix them retroactively. Will they do that again? We'd hope they wouldn't go that highly disruptive route, but it's certainly possible.

#### MOAA's LEGISLATIVE UPDATE for November 12, 2010:

#### Lame Ducks Return to Washington

The lame duck session will begin on Monday, November 15. Congress will have plenty of pressing issues to keep them busy in this brief post-election session. Two actions are particularly critical for the military community and it's not certain whether the lame ducks will even take them up.

#### Military Families Face "Catch-26"

Millions of Americans already are taking advantage of the new authority to continue adult children who don't have access to employer health coverage on their parents' health insurance.

MOAA Government Relations Director Steve Strobridge's As I See It column asks for your help to convince Congress to make that happen for military kids - and drop plans to charge a military-unique \$2,400 annual premium that civilians won't have to pay.

#### Deficit Commission Wants YOU - To Pay Up!

The co-chairs of the President's Commission on Deficit Reduction and Reform startled legislators and the other 16 commission members by pre-emptively announcing a massive package of proposed spending cuts and tax reforms they said would be necessary to get the country back on the right fiscal track.

Former Sen. Alan Simpson (R-WY) and former Clinton White House Chief of Staff Erskine Bowles jumped the gun on the Commission's scheduled Dec. 1 report delivery date by announcing their own co-chairs' recommendation package, to the apparent consternation of some other commissioners.

Under Commission rules, 14 of the 18 commissioners have to agree on whatever recommendations are included in the commission report. Apparently, the co-chairs thought achieving that level of consensus on the bipartisan but politically divided commission would be unlikely, and wanted to make public a sample package to illustrate the drastic sorts of actions that would be needed to fully address the nation's deficit problems.

Their package envisions deep cuts in virtually every category of federal spending, as well as a dramatic simplification of the tax system that would eliminate many popular deductions for homeowner interest, capital gains, and more.

Proposed initiatives affecting the military and veterans' community would, among many other things:

- a.. Change the CPI to depress COLAs for all federal annuity programs
- b.. Require Medicare beneficiaries to absorb a greater share of health costs

- c.. Impose TRICARE fee hikes and implement enrollment fees for all TRICARE programs \
- d.. Reduce COLAs for "early military retirees" (in previous proposals, such wording has meant "before age 60")
- e.. Freeze military and federal civilian pay raises for three years (including housing/subsistence allowances)
- f.. Consolidate commissaries and exchanges
- g.. Eliminate CONUS dependent schools
- h.. Raise the Social Security retirement age to 69 and the early retirement age to 64
- I.. Curtail future Medicare and TRICARE payments to doctors (but stop the immediate 25% cut)
- j.. Require nondisabled vets to pay more to use VA facilities
- k.. Establish legislative requirements for mandatory across-the-board cuts if Congress doesn't act to keep federal spending growth below a specified level

The co-chairs as much as admitted that their package, as a whole, would stand little chance of enactment.

"We've harpooned every whale in the ocean," said Simpson, noting wryly that he and Bowles "might have to go in the witness protection program."

Bowles called it "a starting point" for what's expected to be a protracted and (both fiscally and politically) painful budget battle. "America cannot be great if we go broke," the co-chairs said in their briefing.

Any conscientious citizen must be concerned about America's increasingly severe deficit problems, and addressing those problems will require sober sacrifices on the part of every American.

In that process, MOAA is determined to ensure that government leaders properly acknowledge the government's unique obligation to those who rendered decades of service and sacrifice for the rest of the country, and that any allocation of "shared sacrifice" must recognize that this tiny segment of Americans already has been required to shoulder a vastly disproportional share of national sacrifice.

#### MOAA's LEGISLATIVE UPDATE for November 19, 2010:

#### Big Retirement Cuts for Current Troops?

On Wednesday, the Bipartisan Policy Center released the recommendations of a privately funded Budget Reduction Task Force with the goal of bringing the federal debt below 60 percent of GDP by 2020.

This group, co-chaired by former Senator Pete Domenici (R-NM) and former Congressional Budget Office Director Alice Rivlin, is independent of the President's Commission on Fiscal Responsibility and Reform, whose co-chairs issued a separate deficit-cutting proposal last week (see box above).

Among a broad range of other proposals, the Rivlin-Domenici plan would dramatically alter the military retirement system by:

- \* Shifting it to a 401(k)-style system involving member contributions and variable government matching (depending on skill, retention needs, etc., each year),
- \* Basing retired pay on the highest five years' average basic pay (vs. the current three years),
- Delaying eligibility for immediate retired pay until age
   for those with 20 or more years' service, and

\* Vesting retirement benefits for members with 10 or more years of service

They estimate this would reduce long-term military retirement costs by 50%.

To help achieve those savings, the Rivlin-Domenici plan would shift all currently serving troops with less than 15 years of service to the new system!

MOAA believes the basic proposal is as ill-advised as were similar proposals in years past, in that its fundamental premise is to dramatically cut compensation for people who complete a military career in order to pay people who elect to separate.

It's a formula guaranteed to end in a long-term retention and readiness disaster. If it were in place today and soldiers with 10 years of service facing a third or fourth...or fifth...combat deployment had a choice between leaving with a vested retirement benefit or being forced to serve until age 57 to get an immediate annuity, we wouldn't like the resulting retention rates.

Abrogating retirement promises to all currently serving personnel with less than 15 years of service would add gross insult to grievous injury.

MOAA doesn't believe Congress would stand for it. But having a commission of this stature even propose such a thing is troubling, indeed.

#### VA Secretary Addresses MOAA

Secretary Eric Shinseki spoke to MOAA Council and Chapter leaders from around the country at MOAA's annual meeting Tuesday in Arlington, VA. A former Army Chief of Staff who was wounded in Vietnam, he brought candor and perspective to the daunting challenges of caring for our nation's veterans during the longest conflicts in our nation's history.

Shinseki laid out three broad priorities for the VA: "...increasing access to VA benefits and service, eliminating the disability claims backlog that frustrates all of us, and ending veteran homelessness..." He said that "access" is not only getting the word out to veterans on its programs, but using modern telehealth technologies to provide health services for remotely located veterans.

He acknowledged that the claims intake of almost 100,000 claims per month outpaces the VA's current capacity to process them. Shinseki noted that in 2009 the VA decided almost one million disability claims. He pledged to drive the VA towards an automated system, upgraded training and quality control and to field promising innovations in a variety of pilot programs around the country.

He said the VA's goals - which he acknowledged pose a major challenge - include eliminating the claims backlog and ending veteran homelessness by 2015.

Noting that "dollars are firepower" for VA programs, he applauded Congress for the record increases in VA funding in recent years - and noted the FY2011 VA budget seeks to add \$10 billion to last year's total.

#### MOAA's LEGISLATIVE UPDATE for November 24, 2010:

#### Vets Aren't Taking the Hill

At the start of the 111th Congress of 2009-2010, only 25% of U.S. senators and 21.6% of U.S. representatives had

served at least some period in military uniform (active duty, Guard, or Reserve).

That percentage has been declining steadily since it peaked at 74% for the House (1969-70) and 78% for the Senate (1977-78).

The decline will continue when the newly minted 112th Congress takes office next year.

In the new Senate, there will be 25 vets, including four military retirees - the same figures as the 111th Congress. Senators Mark Kirk (R-IL), Scott Brown (R-MA), and Lindsey Graham (R-SC) are currently serving National Guard or Reserve members.

In the House, a whopping 98 seats turned over. Among incoming freshmen, 22 are veterans, including four military retirees.

Rep Steve Stivers (R-OH) and Reps-elect Tim Griffin (R-AR), Adam Kinzinger (R-IL), Steven Palazzo (R-MS), and Joe Heck (R-NV) are currently serving in the National Guard or Reserve.

The new House will have a total of 87 veterans (20% of voting members), including 10 military retirees -- down from 94 vets at the start of the 111th Congress.

#### MOAA's LEGISLATIVE UPDATE for December 17, 2010:

#### Arlington Cemetery Audit Bill.

The House has cleared a measure sponsored by Sen. Claire McCaskill (D-MO) requiring a full audit of all gravesites Arlington National Cemetery.

#### Defense Bill Deal

After weeks of negotiations, House and Senate Armed Services Committees have struck a bipartisan deal to move the FY2011 defense authorization bill forward.

On Wednesday, House Armed Services Chairman Ike Skelton (D-MO) introduced H.R. 6523, a new version of the bill stripped of several controversial elements, including those involving "don't ask, don't tell" and privately funded abortions in military hospitals.

Senators Levin and McCain stated jointly, "Because of the unique circumstances in which the bill is being considered and the importance of the legislation to our men and women serving in uniform at a time of war, we have agreed to drop many controversial provisions that were included in the House and Senate versions of the bill."

Among many other provisions, the stripped down bill would:

- \* Provide a 1.4% military pay raise
- \* Extend TRICARE coverage for dependent children to age 26, but would require payment of a premium to cover the full cost of the coverage (estimated at \$2,400 per year per child)
- \* Bar any TRICARE Standard inpatient copay increase in FY2011 (that was the only increase at risk this year)
- Prohibit administrative discharge of servicemembers for an injury or illness after being considered by a physical evaluation board and deemed fit to return to duty
- \* Renew a wide range of expiring recruiting and retention bonus authorities

\* Provide \$50 million in impact aid (assistance for civilian schools serving high proportions of military children)

- Require a DoD review of the adequacy of education programs for military spouses
- \* Require improvements to the Yellow Ribbon Guard/Reserve reintegration program (to include authorizing attendance by family members or other designees of a servicemember)

On Friday the house passed the measure, clearing the way for (hopefully) quick action in the Senate.

#### MOAA Recognized for "Doc Fix"

Recognized as the key military partner in winning legislation to reverse a scheduled 25% cut in Medicare and TRICARE payments, MOAA President VADM Norb Ryan (USN-Ret) was invited to attend the White House signing ceremony of the Medicare and Medicaid Extenders Act of 2010 on Wednesday.

President Obama, the leaders of AMA and AARP, and Chairman Baucus of the Senate Finance Committee applauded MOAA's role in highlighting the impact for military beneficiaries and generating more than 300,000 messages to Congress on this topic.

Admiral Ryan, speaking after the event said, "The new law provides a 12-month reprieve, not a fix to the underlying formula problem. But it gives Congress more time to find a long-term solution to a very complex physician payment structure. It makes sure that 2011 won't follow the pattern of 2010, when Congress had to act multiple times to delay the cuts - in some cases for as little as 30 days. It's extremely unsettling to our members to live with these constant threats of imminent loss of health care access."

Winning a permanent fix for the flawed statutory formula continues to be a top MOAA focus for 2011.

#### **GI Bill Victory**

Last week we reported that the Senate was set to consider S. 3447, the "Veterans Benefits Improvements Act of 2010."

We're pleased this bill to improve the Post 9-11 GI Bill was passed by unanimous consent in the Senate, and the House later approved it by a vote of 409-3. The bill now heads to the president for his signature.

MOAA members factored into this victory by sending more than 5,500 messages to Congress in just two days to help spur the on this important fix.

The bill contains many MOAA priorities for upgrading the new GI Bill, including:

- \* Benefits for National Guard members ordered to state active duty (Title 32)
- Vocational, OJT and apprenticeship training, flight training, and other types of non-degree training
- \* A housing stipend for full-time online (distance) learners
- A book allowance for servicemembers and their spouses enrolled while on active duty

- \* An upgraded subsistence allowance for disabled veterans using Vocational Rehabilitation and Employment (VRE) program benefits
- Coverage for multiple licensure and certification tests
- \* Authority to let USPHS and NOAA Corps officers transfer benefits to family members

#### MOAA's LEGISLATIVE UPDATE for December 22, 2010:

#### Tough to Turn Out the Lights

Nothing about the 111th Congress has been easy, and that's true even on what may be its very last day.

On Tuesday night the Senate finalized debate on the defense authorization bill and passed an amended version.

The Senate removed a controversial provision related to Guam that was holding up the defense bill. Leaders on both sides of the aisle agreed to delete the provision and send it back to the House.

In effect, House members were staying in Washington only to give final approval to this last Senate-passed measure, and they did so on Wednesday morning.

As this update was written the defense bill was heading to the President for his signature.

While MOAA appreciates that Democrats and Republicans finally got together to make some necessary compromises, it's exasperating that they couldn't have found a way to do that earlier, without holding legislation that's so vital to the national welfare hostage to political concerns right up until the fifty-ninth minute of the eleventh hour.

#### Government Funding Extended, VA Funding Increased

On Tuesday Congress approved a continuing resolution in order to keep the federal government funded through March 4, 2011. The resolution came just in time to prevent a government lockout as funding for federal government operations would have expired on December 22.

The bill extends most agencies funding at 2010 levels, but it also includes an additional \$460 million for the VA in order to maintain claims processors and help reduce the backlog of claims.

Reducing the claims backlog has been a long-standing goal. More funding was required to keep pace with the swell

of claims brought on by the three new presumptive conditions for exposure to Agent Orange approved by the VA this fall.

The resolution also includes a two years pay freeze for federal civilian employees starting on January 1. Military personnel will not be affected by the freeze, and instead will see a 1.4% pay increase in 2011.

#### Three Tiers for Medicare

Most Medicare beneficiaries won't see any increase in Medicare Part B premiums in 2011. This is because there was no cost-of-living adjustment (COLA) for Social Security annuitants this year.

Beneficiaries with incomes under \$85,000 (or \$170,000 for couples) and who have their Part B premiums withheld from their Social Security will have their premiums frozen at either \$96.40 or \$110.50 per month (depending on when they signed up).

For others, Medicare Part B monthly premiums will be \$115.40 in 2011 - a 4.4 percent increase over the 2010 premium.

This increased premium will affect:

- \* New Part B beneficiaries (because they didn't have the premium withheld from their Social Security benefit in the previous year) and,
- \* Beneficiaries who do not have their Part B premium withheld from their Social Security benefit

As experienced in January 2010, beneficiaries with incomes above the levels cited in the second paragraph of this article also will see higher premiums in 2011, based on the income they reported to the IRS for 2009.

At incomes above those levels, the government subsidy for Medicare is progressively reduced. For most eligibles, the subsidy is 75 percent. As income rises, the subsidy is progressively reduced - to 20 percent for those in the highest income category.

#### **DFAS and Your Tax Documents**

The Defense Finance and Accounting Service (DFAS) announced last week the schedule for release of the end-of-year tax documents.

For retirees and annuitants who have a myPay account, their end-of-year annual statements and 1099Rs are available on the myPay website (https://mypay.dfas.mil/mypay.aspx).
